## Soy good! Record sowing in Gujarat

Soyabean, a high-protein pulse, is finally finding favour with farmers of Gujarat. Driven by growing demand for soy-fortified multigrain flour by the health conscious and its use as high-within of didn'in a with the new conscious and its use as highrutrition fodder in poultry and
inland fish farms, sowing of
soybeans has filt a record 2.4
lakh hectares in August this
year. To put the figure in
perspective, soybean sowing
was negligible in the state until
2014-15. This changed when
Gujarat farmers put 1.2 lakh
hectares of land under soy
cultivation by October 2017.
With people slowly warming
up to the concept of mixing
soy in wheat flour for a plantbased punch in their
vegetarian diets, soybean
sowing has taken place on a
record 2.4 lakh hectares in the
state so far. This figure is only
expected to grow further as
more sowing will take place
till October. Experts cite
multiple factors behind the
sudden interest. Till half a
decade ago, Gujarat farmers
did not evince much interest
in soybeans. Trilok Agarwal,
president of the Gujarat Flour
Mills Association, said that soy
is a key component of
multigrain flour which has
found favour with growing
numbers of health-conscious
families. "Forget branded
multigrain flours, middlenutrition fodder in poultry and

income families are now fortifying their chapati flour with soy flour from local mills to enhance its protein content. Multigrain bread is also available in bakeries," said Agarwal.

Soybean has also found Soybean has also round favour among oil millers as Gujaratis have opened up to using different cooking oils. The bigger lure, however, is the high demand for soya De Oiled Cake (DOC). Poultry and the high demand for soya De Oiled Cake (DOC). Poultry and fish farm owners use it as fodder. "The soy DOCs sell for Rs 50 per kg against Rs 35/kg fetched by groundnut DOCs which is a revenue earner for oil millers," says Sameer Shah, president of the Gujarat State Edible Oil Millers Association. He said that as dietitians advise rotating oils used as a cooking medium, soybean oil is now being manufactured by small oil millers to cater to local demand. Agriculture experts say that many farmers especially in Junagadh and Dahod, have turned to soybean cropp as it fetches them more money than groundnut and maize crops, respectively. "Farmers get Rs 6 000-11 001 per quirter! of 000-10 no per quirter!" grounditut and marze crops, respectively. "Farmers get Rs 6,000-10,000 per quintal of soybean against Rs 4,000-5,000 per quintal of groundnut and Rs 2,00-2,500 for maize," said Iqbal Kharodawala, one of the biggest traders of soybean in Dahod.

# Obstacles to a diplomatic solution in Ukraine



The world is hurtling towards a far-reaching geopolitical and economic crisis, in part precipitated by the war in Ukraine. The secondary effects of the war are now reverberating across are now reverberating across the world. The risks of escalation are increasing. The first priority of the international community has to

international community has to be finding a creative solution that ends this war. But it is becoming equally clear that the world is in the grip of a deadly combination of denial, surrealism and opportunism. Russia's invasion of Ukraine is a moral abomination of the highest order. What else can one call the will to destroy a nation of 40 million? There is no justification for this invasion. Even Putin does not take recourse to the pretexts that his apploigats in Indian circles his apologists in Indian circles provide. It is difficult to predict the course of the war. But it has been clear for a long time that neither: Ukraine nor Russia will achieve the objectives they have stated will count as a victory any time soon. The Ukrainian resistance is heroic; but they will not be able to fully dislodge Russia from Ukrainian territory. The Russian military has not suffered losses that are unsustainable. Russia's nas not suffered losses that are unsustainable, Russia's economy has not been brought to its knees, and the political stakes of a defeat are too high for Putin to let go. It is unconscionable for anyone to ask Ukraine that has sacrificed so much to defend its rights to simply rive un and sacrificed so much to defend its rights, to simply give up and appease Putin. But the war has dragged on long enough that the human cost of the war will become a factor in Ukraine's calculation. Now one might think this is a good time for diplomacy, and many well-meaning

Now one might think this is a good time for diplomacy, and many well-meaning people have called on the G-20 to be the forum to take an active role. But there are three challenges with the diplomatic route. The first is simply that no one quite knows. Putin's endgame, and his political definition of a victory here. He has shown a kind of ruthlessness and expansive ambition, and staked so much nationalist pride on this that the threshold of what it will take to diplomatically pacify him is probably very high already. It's funny that none of the calls for diplomacy are directed at Putin.
